# Vernon C. "Moon" Miller

At 89 years old, Vernon C. "Moon" Miller, lifelong resident of the Greater Dayton Area, and 65 year Member of the Plumbers & Pipefitters Local Union No. 162, is no stranger to bravery, or hard work, or service.

The day he turned 17, on June 7, 1943, Moon Miller signed up with the US Navy, joining two older brothers. Aboard the USS Cincinnati he made the trip across the Atlantic, escorting convoys of troops and equipment, to fight the Nazis in WWII.

The day before he turned 18, on June 6, 1944, at 6:30 am, Moon manned a 3-inch gun, on the starboard side of the USS Cincinnati, firing upon the Nazi stronghold on the cliffs of Normandy. The battle known as D-Day was waged before his eyes. He remembers that none of the guys, including him, thought they would survive the war.

Survive he did, and after his years in the Navy, Moon returned to Dayton, Ohio and worked for NCR. Moon soon got married. His Father-in-law was a Plumber & Pipefitter, and Moon began his apprenticeship. He finished a 5 year apprenticeship in just 3 years to become a Plumber & Pipefitter, and joined the Plumbers & Pipefitters Local Union No. 162.

In those days, the Union did not have programs like, Pension/Retirement Plans or Health & Welfare Plans for its members. In fact, Moon was 42 years old before he first started paying into a pension plan. His Union, the Plumber & Pipefitter Local Union No. 162, made great strides to include programs that help and protect its members over the next 65 years.

Moon is now retired and lives in Huber Heights. In June, 2014, the 70th Anniversary of D-Day, Moon traveled back to France and was honored by the French government for his service on D-Day. He was presented with the French Legion of Honor Medal.

He is also an active member of the VFW 9582, the American Legion 619, and the AmVets 99 in Vandalia, where he serves in the Honor Guard.

If you were wondering, Moon "earned" his nickname at age 5, by getting into his daddy's moonshine.

#### **OSHA Injury Reporting Updates:**

To help employers comply with new requirements to report severe worker injuries, OSHA has created a streamlined reporting webpage and now offers the option of reporting incidents online. The expanded requirements took effect in January 2015. In addition to reporting any worker fatality within 8 hours, now employers must report any severe injury within 24 hours; this is defined as an

*amputation, hospitalization or loss of an eye.* In the first year of the new requirement OSHA received about 12,000 reports. The agency plans to release complete numbers and a full analysis of the Year One reports soon.

#### **Unemployment costs for Ohio employers increased for 2016:**

Maximum claim costs increased from \$14,872 to \$15,262. This is the potential amount an employer can be charged for one unemployment claim.

Maximum unemployment tax rates increased from 8.6% to 8.7%. The minimum tax rate remains 0.3%. Employers continue to pay unemployment taxes on the first \$9,000 of each employee's payroll unless they are exempt from this requirement.

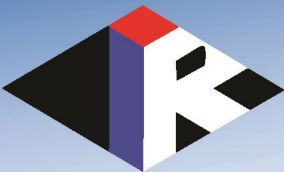
